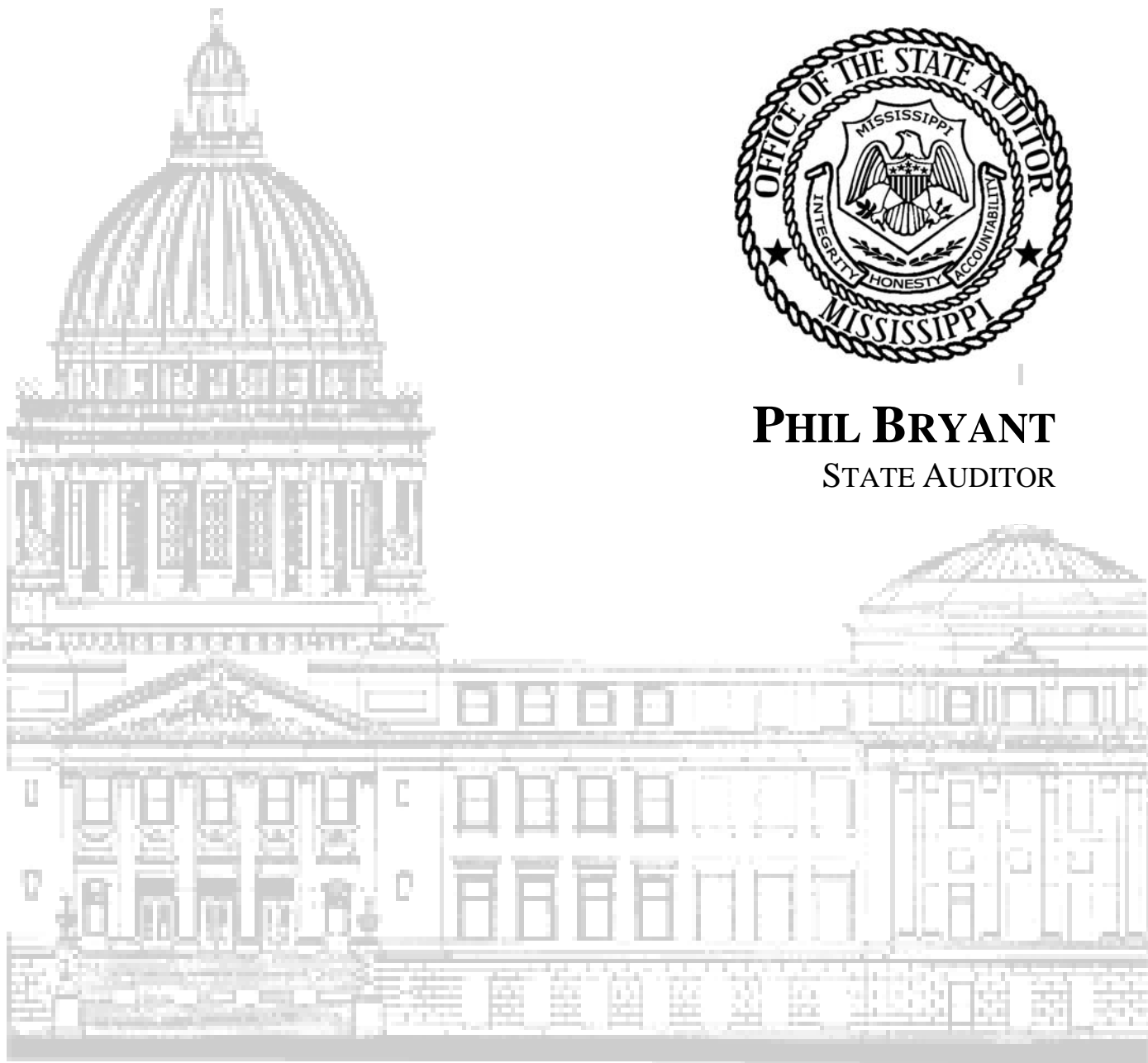

Dear Gentlemen:

As required by Section 37-37-9, Mississippi Code Annotated 1972, I submit, herewith, a comprehensive report of the Mississippi Student Information System (MSIS) examinations made by the office's Average Daily Attendance Audit Division in all Mississippi public schools for the 2006-2007 scholastic year.

MSIS examinations for the 2006-2007 scholastic year started with an evaluation of applicable policies, procedures, and outputs. This evaluation was conducted on a test basis at selected schools in each school district. We evaluated a minimum of three schools in each district. The district's policy and procedure manual was reviewed to ascertain: (1) how data was entered in the student package; (2) how reports were submitted to the State Department of Education, whether it was done at the individual schools or the school district office; and (3) if reports were approved before submission to the State Department of Education and how these reports were produced.

Two audits were performed during the 2006-2007 scholastic year. The first audit began in October 2006, and was designed to review attendance data from MSIS reports and student administrative packages. The amount of time it took a district to release and/or transfer students was reviewed. Also, a review was performed to see how each district/school verified procedures included in their data collection policy. Our findings were discussed with the MSIS contact person for each district and a final report of the findings was submitted to the district's superintendent.

The second audit began in February 2007 for the purpose of following up on corrections made as a result of the first audit. The results of the second audit conducted at each school were discussed with the MSIS contact for each district and a final report of the findings was submitted to the district's superintendent. The results of our audits are included in the attached spreadsheet.

The Office of the State Auditor, Average Daily Attendance Audit Division, examined the Mississippi Student Information System in all Mississippi public schools during the 2006-2007 scholastic year. Attached are the results. During the examinations, the ADA Audit Division reviewed the following standards:

- All schools are required to run monthly holding area reports
- All schools are required to show documentation for each student's excused absence
- All schools should have a verifiable process for approving attendance data to ensure accuracy
- All schools should have a verifiable process for approving monthly student data reports to ensure accuracy
- All schools should have written policies establishing a timeframe for releasing students in MSIS
- All schools should have written policies establishing the requirements for excused absences

The Mississippi Department of Education recommended each public school implement these standards for the Mississippi Student Information System.

The following spreadsheet shows how many schools in each school district met the above listed standards for each audit.
